Essential Duties And Responsibilities

Execute departmental objectives, lead, develop and manage staff to support the cost, quality, technology, and material flow objectives. Specific duties and responsibilities include, but are not limited to the following:

Lead strategically critical projects that bring exceptional value to the company through total cost reduction, key supplier relationships, commodity focus, supplier consolidation, cost/benefit financial analysis, and supplier certification and communication.

Analyze business commitments, customer specifications and other data to plan and develop supply chain strategy/activities.

Develop, implement, and coordinate appropriate activities to resolve issues in area of supply chain to ensure meeting of commitments.

Participate in the identification and development of existing or new suppliers to ensure compliance with program and specification requirements. Collaborate with Quality Assurance to establish and maintain a supplier approval process and maintain an approved supplier list for all required material.

Attend periodic program reviews at Company. Maintain liaison and communicate effectively with suppliers, internal operations, program managers and teaming partners. Coordinate technical problem solving with suppliers.

Develop and manage department budget on expenditures.

Create metrics to measure compliance to supply chain policies and procedures.

Establish and implement new material planning methods.

Establish and maintain effective communication with internal/external customers to facilitate problem identification/resolution. Participate in and support the communication of company philosophy and information throughout the organization.

Lead efforts to develop supply chain excellence practices.

Participate in and/or lead division performance improvement initiatives. Develop initiatives with operations for lead time reduction where a benefit exists.

Manage material quotes supporting customer proposals / "Quote to Win"

Comply with government and appropriate corporate policies and procedures for purchasing/subcontract activities. Develop and implement departmental policies and procedures to assure effectiveness and compliance.

Create a culture of learning; provide development through training, mentoring and assignments. Hire, appraise, discipline, and discharge employees within area of own cognizance in accordance with federal/state law and Company policy and procedure. Assess skills, knowledge and abilities of candidates to make effective hiring and salary decisions and identified developmental needs. Establish and evaluate performance standards and appropriate measurements. Prepare and provide data, reports and metrics to management relating to supply chain and material management.
